RESOLUTION No. 2017- 04

A RESOLUTION TO PARTICIPATE IN A PROPOSED REORGANIZATION WITH THE TOWN OF WHITESTOWN PURSUANT TO INDIANA CODE 36-1.5

WHEREAS, the Town of Whitestown ("Town") and Worth Township ("Worth") are both located in the southern part of Boone County, Indiana, and share many common interests and services within their community; and

WHEREAS, the Town of Whitestown and Worth Township believe that the governmental services provided to their citizens can be consolidated and/or coordinated to provide more effective and efficient government to their citizens; and

WHEREAS, the Indiana General Assembly has provided the mechanism, through Indiana Code Section 36-1.5 and other related statutes, whereby local units of government, with express approval of the citizens of those local units, may enter into mergers, consolidation, and/or cooperative agreements to share the responsibility for providing services in a more effective and efficient manner.

NOW, THEREFORE, BE IT RESOLVED, by the Worth Township Advisory Board as follows:

1. Pursuant to the authority granted under IC 36-1.5, the Town of Whitestown and Worth Township, both in Boone County, Indiana, (collectively, "Participating Political Subdivisions") shall reorganize and/or enter into a Cooperative Agreement as may be appropriate.
2. The reorganization and/or Cooperative Agreement shall be designed to coordinate, consolidate, merge, and/or share the services and functions of the Town and Worth.
3. The legislative bodies of Worth and the Town shall prepare a plan of reorganization, pursuant to IC 36-1.5-4-18 or other statutes that may be applicable.
4. The Township Trustee is hereby authorized and directed to certify, effective this date, and deliver this Resolution to the Whitestown Town Council.
