ORDINANCE 2019-30

**AN ORDINANCE OF THE TOWN OF WHITESTOWN, INDIANA
ESTABLISHING THE WHITESTOWN ECONOMIC IMPROVEMENT DISTRICT**

WHEREAS, the Town of Whitestown, Indiana ("Town") has received a *Petition to Create the Whitestown Economic Improvement District* ("Petition") from property owners within the proposed economic improvement district, pursuant to Ind. Code § 36-7-22; and

WHEREAS, the Town provided notice and conducted a public hearing on the Petition pursuant to Ind. Code § 36-7-22-6; and

WHEREAS, the Petition proposes an economic improvement project for the identification and retention of workers and transportation of workers to be carried out within and to/from the proposed economic improvement district; and

WHEREAS, the Whitestown Town Council, as the legislative body for the Town, finds that:

- (1) the Petition meets the requirements of Ind. Code §§ 36-7-22-4 and -5;
- (2) the economic improvement projects to be undertaken in the district will provide special benefits to property owners in the district and will be of public utility and benefit;
- (3) the benefits provided by the project will be new benefits that do not replace benefits existing before the establishment of the district; and
- (4) the formula to be used for the assessment of benefits is appropriate; and

WHEREAS, the Town Council further determines that the Petition has been signed by (a) at least sixty percent (60%) of the owners of real property within the proposed district, and (b) the owners of real property constituting at least sixty percent (60%) of the assessed valuation in the proposed district, as contemplated by Ind. Code § 36-7-22-7(b), (c), and (d); and

WHEREAS, the Town Council now desires to establish the Whitestown Economic Improvement District and establish the Whitestown Economic Improvement Board under the terms and conditions set forth herein.

NOW THEREFORE, BE IT ORDAINED by the Town Council of the Town of Whitestown, Indiana, as follows:

1. Whitestown Economic Improvement District. The Whitestown Economic Improvement District, comprised of the parcels identified on the map attached

hereto as Exhibit A and incorporated herein, ("District") is hereby established. A list of the current parcels within the District is further attached hereto as Exhibit B.

2. Whitestown Economic Improvement Board. The Whitestown Economic Improvement Board ("Board") is hereby established. The Board shall consist of five (5) voting members ("Members") appointed by the Town Council President with the approval of the Town Council. At least three (3) voting Members must own real property (or be representatives of owners of real property) within the District. Voting Members serve at the pleasure of the Town Council and may be removed or replaced without cause. The voting Members should elect one voting Member to serve as Chairman, and may also elect such other officers from its voting membership as the Board deems appropriate. Three (3) voting Members shall constitute a quorum of the Board.

3. Advisory Board Members. The Town Council President, with the approval of the Town Council, may also appoint up to four (4) non-voting advisory members to the Board. Non-voting advisory members serve at the pleasure of the Town Council and may be removed or replaced without cause.

4. Powers and Duties of the Board. The Board shall manage and implement economic improvement projects approved by the Town Council and related to the identification and retention of workers and transportation of workers to be carried out within and to/from the District. All projects, agreements, or other actions of the Board under Ind. Code § 36-7-22-22 or Ind. Code § 36-7-22-19, shall only be valid with approval of the Town Council. The Board shall submit an annual report to the Town Council before February 15 of each year, summarizing the Board's activities and expenditures during the preceding calendar year.

5. Special Assessment. The Board shall use the following formula for determining the special assessments under Ind. Code § 36-7-22-12 for each parcel in the District: (a) the annual assessed value as determined by the Boone County Assessor's office will be used as the basis for determining the percentage of the total benefit to be received by each parcel of property within the District, with an annual assessment of \$0.0005 times the assessed value for property zoned Industrial, Commercial, and/or Business (including those portions of a PUD or Mixed Use designated or used as Industrial, Commercial, and/or Business); and (b) no annual assessment (\$0) for property zoned and used Agricultural or Residential (including those portions of a PUD or Mixed Use designated or used as Agricultural or Residential) during such year.

Any parcel within the District that is (a) owned by a nonprofit entity that is exempt from property taxation under Ind. Code § 6-1.1-10-16, (b) owned by the state or a state agency or leased to a state agency and is exempt from property taxation under Ind. Code § 6-1.1-10 or any other law, or (c) owned by a political subdivision of the state and is exempt from property taxation under Ind. Code § 6-1.1-10 or any other law, is exempt from the special assessment during the same time that such parcel is exempt from property taxation.

The special assessments under this section may be assessed for a period of ten (10) years beginning 2020, payable in semi-annual installments.


6. Whitestown Economic Improvement Fund. There is hereby established the Whitestown Economic Improvement Fund ("Fund"). The Fund shall be a non-reverting fund of the Town. All assessments received under Ind. Code § 36-7-22 and any other amounts received by the Board shall be deposited in the fund. Any money earned from investment of money in the Fund becomes a part of the Fund. All receipts and expenditures attributable to the Fund shall be processed, appropriated, claimed, and allowed in the same manner as other claims of the town. Money in the fund may be expended only with approval of the Town Council. Payments for contracts, agreements, or leases approved by the Town Council shall be considered pre-approved claims.

7. Effective Date. This Ordinance shall be effective upon its adoption as required by law.

Introduced on December 18, 2019, and adopted by the Town Council of the Town of Whitestown, Indiana, on this 18th day of December, 2019.



Whitestown Economic Improvement District

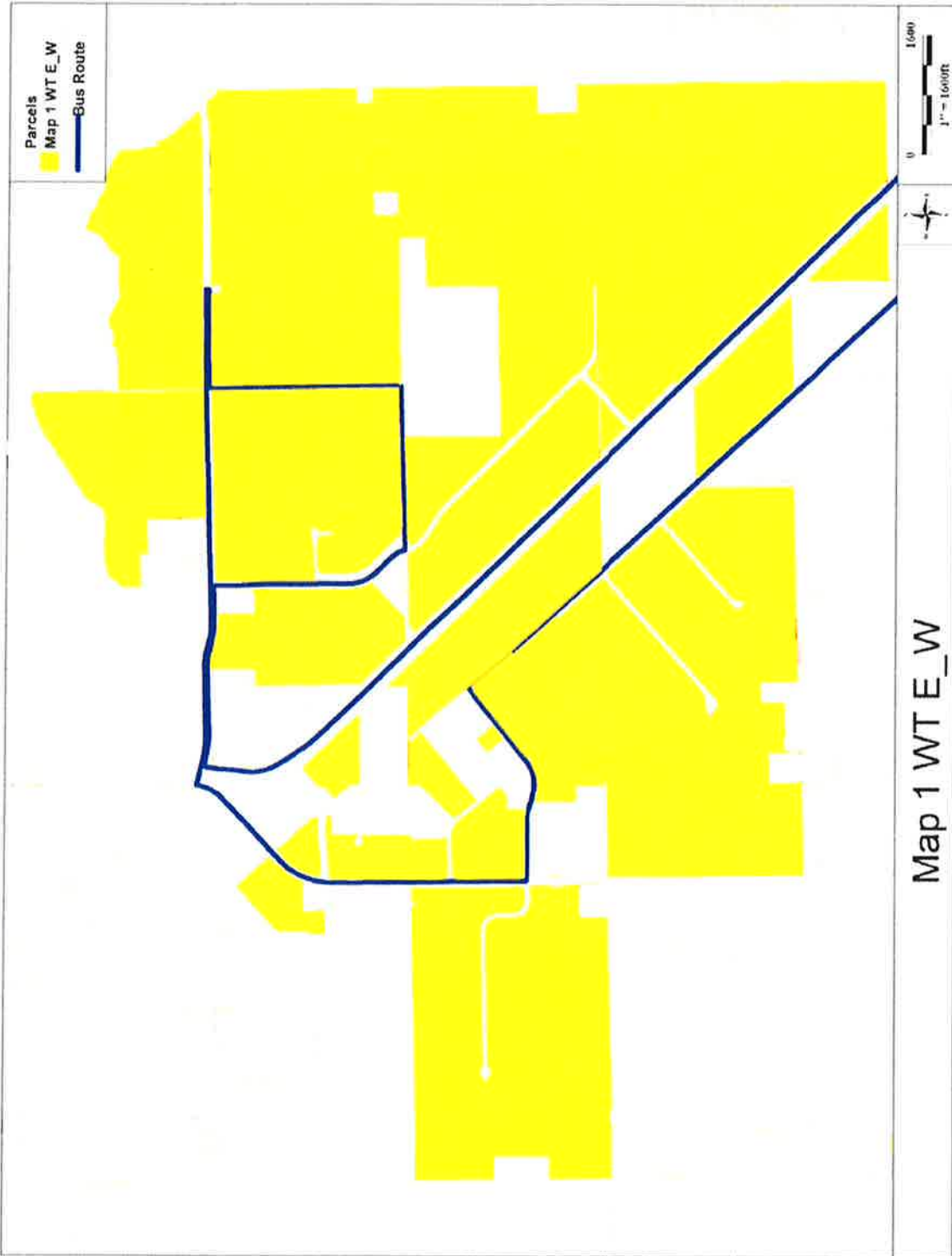
