We propose to furnish labor and materials necessary for completion of the following scope-of-work, for sum of: **Forty-Eight Thousand Nine Hundred Nine and.....50/100 dollars \$48,909.50**

Excavate, Stone, and Pave New 8' Walking Path

1. Cut existing asphalt, concrete, and sub-grade to a depth of +/- 9" haul off site.
2. Place, grade, and compact 6" of #53 Limestone (approximately 305 ton).
3. Any additional stone necessary to ensure proper base and drainage will be figured at \$25.00 per ton.
4. Lay hot over sanded asphalt binder and roll to a compacted depth of 3".
5. Approximately 6,984 square feet.

Remove existing markings by grinding: stop bar

Install thermoplastic on asphalt: stop bars

Remove and relocate: 2 existing "Stop" signs on 2 existing posts driven in landscape

Delello and Sons Asphalt paving will not responsible for installation of backfill or top soil and seed/sod after the asphalt construction is complete. Dirt will not be set to rough grade. Any dirt work after asphalt construction is complete will be the responsibility of Whitestown.

One-year guarantee on all labor and materials.
