General Updates

Whitestown Metropolitan Police Department has been working diligently to accomplish the following:

- 2021 New Hires
 - 5 of the 6 new hires have successfully completed their Field Training Program and are currently assigned to their permanent shifts.
 - PSO Frank Wolfe is currently at the Indiana Law Enforcement Academy and has successfully completed 4 of his 16 weeks of training. PSO Wolfe is scheduled to graduate the Police Academy in September.
 - Upon successful completion of Field Training, PSO Whitney Lushin was added to the K9 Division with his K9 partner "Al". PSO Lushin and his partner were assigned to day shift.
- Physical Abilities Test (PAT)
 - Whitestown Officers completed their voluntary bi-annual PAT.
 - The assessment consisted of 4 strength assessments measuring our upper body, lower body, and core strength. After the strength assessments officers completed an obstacle course that measured their work capacity and tactical agility.
 - WMPD 100% participation rate shows our dedication to physical wellbeing.
- Dan Boutwell, Director of Code Enforcement for Whitestown
 - This June was a bittersweet moment for WMPD, as Dan transitioned from WMPD to the Director of Code Enforcement. Dan started his law enforcement career in 1994 for Marion County before coming to Whitestown. In his time at Whitestown, Dan has dedicated his service and love for the community by acting as Town Marshal, Lieutenant of Investigations, and Day Shift Patrol Sergeant.
 - WMPD would like to thank Dan for his years of service, infectious humor, and wish him luck has he continues to serves the Town of Whitestown and the community in his new role.
- · Certified Breath Test Machine
 - A Certified Breath Test Machine was put in by the State Dept. of Toxicology. This is a tool WMPD and surrounding agencies can utilize to remove impaired drivers from the roadway. This is the 3rd machine in Boone County.



Training Division

- Physical tactics instructors attended a Gracie University instructor course at the Indiana Law Enforcement Academy. This course taught instructors Jiu-Jitsu control tactics and associated principles.
 - This course provided the foundational knowledge needed to ensure WMPD's physical tactics program is current and uniform among instructors.
- · Department Training
 - One officer successfully completed the Indiana Law Enforcement Academy's Firearm Instructor Course.
 - WMPD & Lebanon Police hosted gun liaison training.
 - WMPD currently has 6 gun liaisons for the department. This unit helps secure
 convictions on firearm related crimes. This officers are trained to locate and extract DNA
 from weapons.
 - Bike Patrol School
 - Two officers attended bike patrol school. These officers will be out in the neighborhoods conducting their patrols on bicycles.
 - Amber Alert
 - Supervisors and investigators attended online Amber Alerts training. Online training discussed initial strategies and tactics when responding to missing and engendered children. In addition, training went over best practices for Amber Alert.
