Sunscreening also is permitted for medical reasons and a medical certificate must be carried in the vehicle.

Failure of disabled truck, bus, or trailer to display warning flags where required. This applies only to highways outside municipalities.

Failure of disabled vehicle carrying explosives to display warning devices during non-daylight hours. This applies only to highways outside municipalities.
