MONTHLY REPORT: SEPTEMBER

General Update

Whitestown Metropolitan Police Department has been working diligently over the last month to accomplish the following goals:

1. Implemented Police One Academy:

- Online training program that provide officer's with more frequent, up-to-date training.

2. Implemented Officer Wellness Program:

- Program provide officer's with mental health and overall wellness support. The program provides officers an avenue to talk with mental health professionals along with peers to manage the potential stressors officer experience on a daily basis.

Community Involvement

The Whitestown Police Department values and appreciates our community members voices and concerns. This month we received multiple complaints of individuals speeding in Clark Meadows neighborhood. Officers responded with additional enforcement:

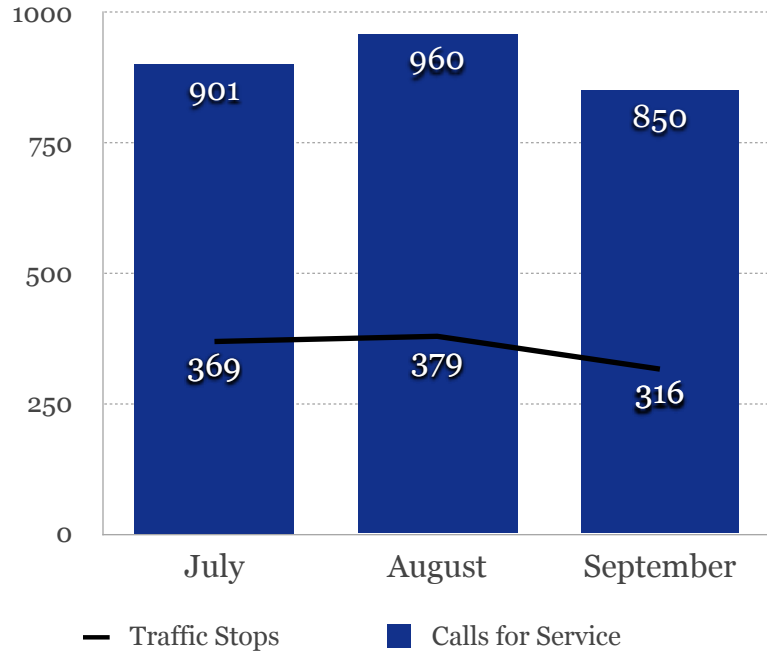
- Conducted **52** enforcement actions to slow vehicles down: **10 extra patrols, 42 traffic stops.**
- **8** Whitestown Police Officers along with their families participated in the Beyond the Badge 5k held at Crown Hill Cemetery.

Monthly Statistics

Patrol Division

- Officers have increased their enforcement activities along with an increased number of dispatched calls.
- Officer’s enforcement activity yielded the following case and arrest reports.
 - **54 Arrests Reports** (# of individuals charged with a crime):
 - **161 Case Reports** (any criminal or necessary documentation)
- Reserves officers volunteered **202 hours** of their time to our Whitestown community.

Investigations

- Our detectives have been diligently working to investigate various crimes within Whitestown. These crimes are classified into **3 primary categories**: *crimes against property* (thefts, hit and runs, criminal mischief, etc...), *crime against person* (battery, burglary, sexual misconduct, etc...), and *cyber investigations* (forensic examination of telecommunication devices: computers, external hard drives, phones)
- Detectives are currently working 18 active cases, refer to graph below for case load breakdown.

Training

- K9 units were deployed 8 times for various tasks (apprehension, free air sniff, tracking). Canine handlers put in 60 hours of training with their furry partners.
- Two supervisors successfully completed Force Science Certificate program.
 - This program educated officers on the human factors that impact officers ability to make decisions in high stress rapidly evolving situations.
- To enhance cultural competency and foster positive communication, all officers participated and completed training on cultural diversity.
 - The course teaches officers how to examine factors that make up our individual cultures and the ways by which culture and law enforcement can merge.
- Officers participated in firearms training.
- All officers completed annual state training requirements.
- Three officers were sent to field training school.
 - Field training school teaches field trainers how to develop, navigate, and transition new officers into the complexity of police officers.
