**Reedy** presented about the budget with the projected growth and revenues of the town. Discussion ensued.


- A. Town - Nathan** talked about how one of the biggest changes is moving Facility under the Town's budget.

- C. Planning/Building** – Council asked about the combined budget and if it required additional software. **Todd** talked about the addition of a new inspector and new vehicle. Discussion ensued.
- D. MVH – Danny** talked about his budget and a new Community Crossings Grant as well as the rest of the budget. Discussion ensued.
- E. Public Relations – Kim** talked about her budget and how the numbers are basically the same as the amounts in the current budget with updates to insurance, etc.
- F. Parks – Savannah** talked about how she has combined supply lines and how most of the budget has remained the same for 2021.
- G. Fleet – Jeff** said this was the same budget as the previous year.
- H. Police – Chief Rolston** talked about how the biggest increase is in personal services due to the growth in the town and discussed the rest of his budget.

- I. **Fire – Chief Lanham** talked about the fire station but still do not have a new date to get into the building. They are planning on hiring 6 additional employees and have increased Other Services and Charges due to adding an additional ambulance and the additional fuel for the vehicle. Discussion ensued.

**3 ADJOURN – Susan m/m to adjourn, Eric 2<sup>nd</sup>, 5-0 adopted.**


