Assistant Chief attached is a quote from Magnet Forensics for Magnet Axiom software. Magnet has partnered with GrayKey to develop Axiom. Recently I utilized Axiom at Fishers PD on a case and was able to find evidence that Cellebrite was not able to find. Axiom will be a great addition to the cyber forensic unit.

In addition, Axiom is a dual-purpose software. It is made to forensically examine computers and cell phones. The trio of Axiom, Cellebrite, and Paraben will make the cyber forensic unit a more proficient unit and will become a greater asset to Boone County.

I have attached a quote to this letter here is the breakdown:

\$5,600 for the initial software setup \$1,500 for the cloud analyzer software \$4,795 for the Training Annual Pass \$25 for shipping Total cost: \$11,920.00

\*\*\*I have secured a gift of \$2,000 from Operation Underground Railroad for Axiom\*\*\*\*

The annual renewal cost will be \$2,000-\$3,500 depending if we renew the cloud analyzer.

The training pass is normally priced at \$5,795 but I was able to negotiate a discount. Axiom offers 8 courses with seven of them being online. There would be no extra cost for the online courses. The normal cost for each course is around \$3,000. The pass would also give me access to the annual training summit that Axiom holds. This summit would give me a great opportunity to network and I would be able to attend a training course while there. The summit will take place in Nashville, TN on May 11-May 13, 2020.

In closing, Axiom will take our investment in GrayKey to the next level and will give me the ability to examine computers and cell phones.
