I. SERVICES BY CONTRACTOR

A. PROJECT DESCRIPTION

The Big Four Trail extension will be a bituminous multi-use trail, 10 feet wide, and approximately 0.75 miles in length. The trail will begin at the existing 90-degree curve at County Road 400 South / County Road 500 South to the east end of the existing segment of the Big Four Trail (along the former Conrail Railroad corridor). Approximately 800 feet of the proposed alignment could potentially utilize a raised boardwalk design to minimize impacts to a suspected wetland.

B. PROJECT SCOPE

- 1. Furnish Basic Design Services as described in detail below:
 - a. The **CONTRACTOR** shall provide finalized waters reconnaissance and wetland delineation in the following outline:
 - Jurisdictional determination forms will be completed along with a wetland report.
 - ii. This report will not include mitigation measures.
 - b. The **CONTRACTOR** shall provide the design, the layout, and configuration of the bituminous trail and boardwalk for the entire length of the trail, including connections to existing trails and street crossings.
 - c. The CONTRACTOR shall prepare all designs and construction plans, for the Big Four Trail extension, based on it being partially funded with Next Level Trails funds and in compliance with guidelines, specifications, and standards of the Indiana Department of Natural Resources and Town of Whitestown, Indiana.
 - d. The **CONTRACTOR** shall develop the design and construction documents in accordance with the following outline:
 - i. Preliminary Plans (Scope Confirmation and Grade Review, 30%)
 - 1. Conduct initial site visit with survey data in hand.
 - 2. Develop preliminary layout of trail on plan and profile sheets
 - 3. Develop typical cross sections
 - 4. Attend one (1) progress meeting with WHITESTOWN

II. SERVICES BY WHITESTOWN

WHITESTOWN shall, within a reasonable time, so as not to delay the services of the CONTRACTOR:

- Provide full information as to CONTRACTOR's requirements for the Project.
- Assist the CONTRACTOR's by placing at CONTRACTOR's disposal all available information pertinent to the assignment including previous reports and any other data relative thereto.
- 3. Examine all studies, reports, sketches, Drawings, Specifications, proposals and other documents presented by CONTRACTOR, obtain advice of an attorney, insurance counselor, and other consultants as WHITESTOWN deems appropriate for such examination and render in writing decisions pertaining thereto within a reasonable time so as not to delay the services of CONTRACTOR.
- 4. Give prompt written notice to the **CONTRACTOR** whenever **WHITESTOWN** observes or otherwise becomes aware of any defect in the Project.
- 5. Furnish all existing approvals or permits from all governmental authorities having jurisdiction over the Project. The **CONTRACTOR** will assist **WHITESTOWN** in identifying and procuring any additional permits associated with this Project.
- Arrange for access to and make all provisions for the CONTRACTOR to enter upon public and private property as required for the CONTRACTOR to perform services under this Agreement.
- 7. Obtain necessary easements and right-of-way for construction of the Project, including easement and right-of-way descriptions, property surveys and boundary surveys.
- 8. Furnish to the CONTRACTOR, as requested by the CONTRACTOR or as required by the Contract Documents, data prepared by or services of others, including exploration and tests of subsurface conditions at or contiguous to the site, drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the site.

III. SCHEDULE

All work by the **CONTRACTOR** under this Agreement shall be completed and delivered to **WHITESTOWN** for review and approval within the approximate time periods shown in the following schedule:

Preliminary Plans: 30 days from NTP

IV. COMPENSATION

A. Amount of Payment

- 1. The **CONTRACTOR** shall receive as payment for the work performed under Item 2 below, the total fee not to exceed \$9,000.00, unless a modification of the Agreement is approved in writing by **WHITESTOWN**.
- 2. The **CONTRACTOR** will be paid for the following work on a lump sum basis in accordance with the following schedule:

B. Method of Payment

Payment shall be made by **WHITESTOWN** to the **CONTRACTOR** each month as the work progresses.
