

**ORDINANCE 2019-06**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE  
TOWN OF WHITESTOWN, INDIANA  
AMENDING ORDINANCE 2018-33 (2019 SALARY ORDINANCE)**

WHEREAS, on December 19, 2018, the Town Council of the Town of Whitestown, Indiana (“Council”) adopted Ordinance 2018-33, An Ordinance of the Town Council of the Town of Whitestown, Indiana, Establishing Wages and Salaries for 2019, which may be amended from time to time (“2019 Salary Ordinance”); and

WHEREAS, the Town Council desires to correct the Salary Matrix for the 2019 Salary Ordinance to clarify that there are two (2) full-time Fire Department Division Chiefs; and

WHEREAS, the Town Council further desires to add a part-time position for a Computer Forensic Examiner in the Police Department; and

WHEREAS, the Town Council further desires to reaffirm and clarify that maximum salaries in the 2019 Salary Ordinance are pro-rated, such that the not-to-exceed or maximum amounts are proportionately reduced after each pay period during a calendar year.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Whitestown, Indiana, as follows:

1. The 2019 Salary Matrix set forth in Exhibit A to the 2019 Salary Ordinance (“Salary Matrix”) is hereby amended to correct/add the following number of positions and corresponding wages/salary:

<u>Position</u>	<u>Wages/Salary</u>	
	<u>Minimum</u>	<u>Maximum</u>
Fire Department Division Chief Full-Time (2)	\$70,000	\$80,000
Fire Department Division Chief Part-Time	N/A	N/A
Police Department – Computer Forensic Examiner - Part-time Civilian	\$15/hr	\$35/hr

2. All maximum salaries and not to exceed amounts set forth in the Salary Ordinance are prorated for the calendar year, such that the maximum amount is reduced pro-rata by the maximum amount available at each pay period.
3. The amendments set forth above supersede any inconsistent provisions in the 2019 Salary Ordinance. All other portions of the 2019 Salary Ordinance, including the corresponding Salary Matrix, shall remain in full force and effect.

4. This Amendment to the 2019 Salary Ordinance shall take effect immediately upon its adoption. Increases or changes in the payment schedule, when implemented, will be pro-rated prospectively.
