All county, school & township tax are captured in the county TIF, this is just a TIF of the county portion of the tax. We are just instating that TIF to help fund some infrastructure projects to develop that site.

**April Witthoeft** asks if this is going to extend the current TIF that is in place right now for Anson South.

**Dennis Otten** states this parcel will have its own clock so the previous will not matter.

**Kyle Weathers** confirms that this is to break down the towers and help alleviate traffic through neighborhoods with the new road.

G. TIF Pledge Resolution for Milhaus TIF Bonds (Resolution 2021-15) | Resolution

H. Project Wagon Tax Abatement Resolution (Resolution 2021-16) | Resolution | Exhibit A

Molly Whitehead with Boone EDC has been working with Style Link Logistics (EC Best Service) is an international Chinese company, e-commerce retail, taking Strategic Capital Building #4. Anticipating employing 500 people paying around \$16 an hour (base pay). Making a \$3.5 million capital investment in this property. Boone EDC recommending 4-year personal property tax abatement, 25% step down each of those years and it is estimated around \$98,000 in savings.
