A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WHITESTOWN, INDIANA FOR THE TRANSFER OF PERSONAL PROPERTY TO THE BOONE COUNTY PROSECUTOR'S OFFICE

WHEREAS, the Town Council for the Town of Whitestown, Indiana (respectively, "Town Council" and "Town") desires to transfer to the Boone County Prosecutor's Office ("BCPO"), for use by the BCPO, a certain 2013 Chevrolet Tahoe PPV (White) with VIN # 1GNLC2E00DR174832, which is no longer needed by the Whitestown Police Department ("Property"); and

WHEREAS, BCPO desires to accept the transfer of the Property; and

WHEREAS, Indiana Code § 5-22-22-10 allows the Town to transfer the Property to BCPO for any amount of property or cash as agreed upon by the governmental bodies, as evidenced by the adoption of substantially identical resolutions by each entity.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Whitestown, Indiana, as follows:

1. The transfer of the Property to BCPO in accordance with Indiana Code § 5-22-22-10 is hereby approved for the payment of \$10 and other good and valuable consideration, the sufficiency of which is acknowledged by the Town. The Town Council President and/or Whitestown Police Chief is/are hereby authorized to execute any and all documents and take such actions as may be necessary to complete such transfer. The Property is transferred "AS IS" and "WHERE IS" and "WITH ALL FAULTS", and the Town makes no warranties of any kind, express or implied, regarding the Property, its quality and/or condition, or otherwise, and all warranties, including but not limited to warranties of merchantability or fitness for a particular purpose, are expressly disclaimed.
