

Gateway Park RFP

The Parks staff has been working over the past months to put together and review a two-phase RFP package for the addition of a playground at Gateway Park. The Park was awarded a LWCF grant to match some of our funding in the form of a reimbursement. The following documentation includes a scoring form on how each RFP scored compared to the others. Based off the scoring guidelines, our department has chosen to go with Sinclair Recreation/Gametime. Also included are the proposed renderings and their associated quotes.

Due to shipping delays, materials shortages, and our proposed timeline the parks staff will be working with the Gametime staff to reconfigure the playground and combine to ensure we are able to get the playground finished in a timely manner that follows our grant timeline and proposed project timeline. Due to this, the budget may go over the initially quoted \$250,000.


