

**ORDINANCE 2021-13**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE  
TOWN OF WHITESTOWN, INDIANA  
AMENDING ORDINANCE 2020-30 (2021 SALARY ORDINANCE)**

WHEREAS, on December 9, 2020, the Town Council of the Town of Whitestown, Indiana ("Council") adopted Ordinance 2020-30, An Ordinance of the Town Council of the Town of Whitestown, Indiana, Establishing Wages and Salaries for 2021, which may be amended from time to time ("2021 Salary Ordinance"); and

WHEREAS, the Town Council desires to amend the 2021 Salary Ordinance to provide for the addition of position and change of title for certain Street Department employees from "Street Department Laborer" to "Street Department Technician"; and

WHEREAS, the Town Council desires to amend the 2021 Salary Ordinance to provide for the addition of position and change of title for certain Water Department employees from "Water/Utility Laborer" to "Water Distribution Operator"; and

WHEREAS, the Town Council desires to amend the 2021 Salary Ordinance to decrease the number of positions and provide a change of title for certain Wastewater Department employees from "Collection System Laborer" to "Collection System Operator"; and

WHEREAS, the Town Council desires to amend the 2021 Salary Ordinance to provide the addition of a position in the Waste Water Department with the addition of the position of "Wastewater Treatment Plant Operator" in lieu of one of the prior Collection System Laborer positions; and

WHEREAS, the Town Council desires to amend the 2021 Salary Ordinance to provide for the creation of a Director of Code Enforcement position in lieu of a Code Enforcement Officer.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Whitestown, Indiana, as follows:

1. The 2021 Salary Matrix set forth in Exhibit A to the 2021 Salary Ordinance ("Salary Matrix") is hereby amended to add the following position and corresponding salary under Public Works/MVH:

<u>Position</u>	<u>Wages/Salary</u>	
	<u>Min</u>	<u>Max</u>
Street Department Technician (5)	\$15/hr	\$25/hr

The Street Department Laborer position is removed from the Salary Matrix.

2. The 2021 Salary Matrix set forth in Exhibit A to the 2021 Salary Ordinance (“Salary Matrix”) is hereby amended to add the following position and corresponding salary under Public Works/MVH:

<u>Position</u>	<u>Wages/Salary</u>	
	<u>Min</u>	<u>Max</u>
Water Distribution Operator (3)	\$15/hr	\$25/hr

The Water/Utility Laborer position is removed from the Salary Matrix.

3. The 2021 Salary Matrix set forth in Exhibit A to the 2021 Salary Ordinance (“Salary Matrix”) is hereby amended to add the following positions and corresponding salaries under Public Works/MVH:

<u>Position</u>	<u>Wages/Salary</u>	
	<u>Min</u>	<u>Max</u>
Collection System Operator (3)	\$15/hr	\$25/hr
Wastewater Treatment Plant Operator (1)	\$15/hr	\$25/hr

The Collection System Laborer position is removed from the Salary Matrix.

4. The 2021 Salary Matrix set forth in Exhibit A to the 2021 Salary Ordinance (“Salary Matrix”) is hereby amended to add the following position and corresponding salary under Maintenance:


<u>Position</u>	<u>Wages/Salary</u>
Director of Code Enforcement	Max \$65,000/year

The Code Enforcement Officer position is removed from the Salary Matrix.

5. This Amendment to the 2021 Salary Ordinance shall take effect immediately upon its adoption. Increases or changes in the payment schedule, when implemented, will be applied or prorated prospectively.
6. The amendments set forth above supersede any inconsistent provisions in the 2021 Salary Ordinance. All other portions of the 2021 Salary Ordinance, including the corresponding Salary Matrix as set forth in Exhibit A thereto and all prior amendments thereto, shall remain in full force and effect.

Adopted by the Town Council of the Town of Whitestown, Indiana, on April 14, 2021 by a vote of 4 in favor and 0 against.
