A JOINT RESOLUTION AMENDING THE FEE SCHEDULE FOR EMERGENCY
AMBULANCE SERVICES.

WHEREAS, on February 27, 2009, Worth Township of Boone County, Indiana ("Worth" or "Township") and the Town of Whitestown of Boone County, Indiana ("Whitestown" or "Town") entered into an Interlocal Cooperation Agreement for Fire Protection and Emergency Services ("Agreement"), providing, in part, for the long-term provision of fire and emergency services in and around Worth and Whitestown; and

WHEREAS, IC § 16-31-5-1 authorizes towns and townships to establish and provide emergency medical services, including emergency ambulance services, and to establish and collect reasonable fees for emergency medical services; and

WHEREAS, in 2015, Whitestown and Worth adopted a Joint Resolution Authorizing the Whitestown Fire Department to Provide Emergency Ambulance Services, Establishing the Emergency Ambulance Services Territory Establishing a Special Non-Reverting Revenue Fund for Emergency Ambulance Services and Establishing a Fee Schedule for Emergency Ambulance Service ("Joint Resolution"); and

WHEREAS, the Joint Resolution established a fee schedule for emergency ambulance service; and

WHEREAS, Whitestown and Worth desire to amend the fee schedule to reflect current costs; and

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Whitestown, Indiana, and the Worth Township, Indiana Advisory Board as follows:

- 1. Section 7 of the Joint Resolution is hereby amended to provide the following fee schedule for emergency ambulance services provided by the WFD for residents of the Service Territory:

| Service | Rate |
|--|---------------|
| Basic Life Support | \$850.00 |
| Advanced Life Support | \$1,100.00 |
| Advanced Life Support- Level II | \$1,400.00 |
| Advanced Life Support Signature of Release | \$250.00 |
| Mileage | \$18.00/ mile |


(b) The Joint Resolution is hereby amended to provide the following fee schedule for emergency ambulance services provided by the WFD for non-residents of the Service Territory:

| Service | Rate |
|--|---------------|
| Basic Life Support | \$1,200.00 |
| Advanced Life Support | \$1,600.00 |
| Advanced Life Support - Level II | \$2,000.00 |
| Advanced Life Support Signature of Release | \$250.00 |
| Mileage | \$18.00/ mile |

2. The amendments set forth above supersede any inconsistent provisions in the Joint Resolution. All other portions of the Joint Resolution shall remain in full force and affect.

PASSED AND ADOPTED by the Town Council of the Town of Whitestown, Indiana, on January 12 2022 by a vote of 5 in favor and 0 against.





