## TOWN OF WHITESTOWN, INDIANA RESOLUTION NO. 2022-20

## A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WHITESTOWN, INDIANA REGARDING AN AMENDMENT TO THE COMPREHENSIVE PLAN (2015)

**WHEREAS,** The Town Council for the Town of Whitestown, Indiana ("Town Council" and "Whitestown" respectively) adopted a comprehensive plan in 2015; and

**WHEREAS,** a comprehensive plan is appropriate to promote the public health, safety, morals, convenience, order, and/or the general welfare of the community; and

WHEREAS, the Indiana Code authorizes amendments to the comprehensive plan; and

**WHEREAS**, the Town Council has determined that amendments need to be made to the 2015 comprehensive plan; and

**WHEREAS**, community input was gathered through virtual meetings, community events, social media, websites, a public online survey, and other channels to gauge the public's priorities for Whitestown; and

**WHEREAS**, an Amended Comprehensive Plan will serve as a helpful guide for the Town's future growth and development, based on examining existing and future conditions, examples of planning practices from around the state, and input from stakeholders; and

**WHEREAS**, the Whitestown Plan Commission at its July 11, 2022 meeting voted to send a favorable recommendation on the Amended Comprehensive Plan, a copy of which is attached hereto as <u>Exhibit A</u>, to the Town Council by 5-0 vote.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of Whitestown, Indiana as follows:

<u>Section 1.</u> The Amended Comprehensive Plan attached hereto as <u>Exhibit A</u> is hereby adopted as the Comprehensive Plan of the Town of Whitestown, Indiana.

<u>Section 2</u>. Any portion of other resolutions or comprehensive plans preceding this Resolution in conflict with a provision in this Resolution is hereby superseded to the extent inconsistent herewith.

<u>Section 3</u>. The provisions of this Resolution and the Amended Comprehensive Plan are severable. In the event any one or more of the provisions contained in this resolution or the Comprehensive Plan should be invalid or unenforceable in any respect, the validity, legality, and enforceability of the remaining provisions contained herein, shall not in any way be affected or impaired and shall remain in full force and effect.

<u>Section 4</u>. This Resolution shall be in full force and effect from and after its passage.
