Pat Palenstine** spoke up and was upset with the Town not following the comprehensive plan and allowing the developer to move forward with the proposal which will end up causing flooding around their home. She stated she was angry that the Town doesn't answer questions about the development. **Brian Tuohy**, who represents the developer, spoke about the previous comments. **Clinton m/m to adopt, Eric M 2nd, 4-1 adopted.**

First Read Only: BPD Super-Voluntary Annexation (**Ordinance 2023-03**) – **Clinton did the first read of the ordinance and Cheryl** came up to speak, she then asked what the Council considers Legacy Core. She then talked about this item, and asked about this not being in the Comp Plan and how one area is low density and was interested in seeing what happens with this moving forward.
- B. Consider Adoption of Ordinance Amending 2023 Salary Ordinance (**Ordinance 2023-04**) – **Clinton did the first read of the ordinance and m/m to suspend the rules for a 2nd read, Eric N 2nd, 5-0 approved. Clinton then did the 2nd read and m/m to adopt, Eric N 2nd, 5-0 adopted.**

8. OTHER BUSINESS - none


9. ADJOURN – Clinton m/m to adjourn, Susan 2nd, 5-0 adjourned.




