#### Minutes

#### 1. OPENING THE MEETING

- A. Call to Order Clinton called the meeting to order at 7:01pm
- **B.** Roll Call **Eric** absent
- **C.** Pledge of Allegiance
- D. Susan m/m to move item F under New Business to Item B and shifting the rest down, Clinton 2<sup>nd</sup>, 4-0 adopted.

#### 2. CLERK TREASURER REPORT

- A. September Town Management Report I September WMU Management Reports (Sewer, Water) \*\* - Dax said there will likely not be any addition appropriations.
- 3. DEPARTMENT REPORTS DPW (Water Monitoring, Street Dept., WMU), Planning and Community Development, Building Department, Parks, Police (Operations, Stats, Drug Stats), Fire\*\* - Clinton called Chief Westrich to the podium and complimented him and Chief Crafton for serving on Task Force One and being deployed to the last and current hurricane. Susan called Nathan to the podium to compliment him on his helping The Sunshine Society. Kevin said he and Nathan have talked about handicap access at the various parks.
- 4. PUBLIC REQUEST TO SPEAK Dax welcomed the students here for their school project.

# 5. APPROVAL OF THE CONSENT AGENDA

- A. Approval of Meeting Minutes Claims September 2018 Expenses Town I September 2018 Revenues Town I September 2018 Utility Claims (September Water Operating, September Wastewater Operating) \*\*
- B. Authorize the utility and legal staff to monitor, review, intervene, and take any other legal or other action necessary or appropriate to protect the Town's interests in Citizen's IURC proceedings relating to sewer rates or service. Susan m/m to approve the above consent agenda, Kevin 2<sup>nd</sup>, 4-0 adopted.



#### 6. UNFINISHED BUSINESS

A. Consider an Ordinance Approving the 2019 Budget (Ordinance 2018-24, Second Read) – Susan did 2<sup>nd</sup> read and m/m to adopt, Clinton 2<sup>nd</sup>, 4-0 adopted.

# 7. NEW BUSINESS

- A. Consider an Ordinance Amending Ordinance 2017-44 (2018 Salary Ordinance) (Adding Additional Parks Maintenance Tech and Increase NTE for Building Department Director) (Ordinance 2018-28, First Read) Susan did first read. Kevin asked if this needs to be passed tonight, Nathan said it does. Kevin m/m to suspend the rules to have 2<sup>nd</sup> read, Susan 2<sup>nd</sup>, 4-0 adopted. Susan did 2<sup>nd</sup> read and m/m to adopt, Kevin 2<sup>nd</sup>, 4-0 adopted.
- B. Consider an Ordinance Approving a Transfer of Appropriation (Ordinance 2018-29, First Read) – Clinton did first read. Susan m/m to suspend rules for 2<sup>nd</sup> read, Kevin 2<sup>nd</sup>, 4-0 approved. Clinton did 2<sup>nd</sup> read, Susan m/m to adopt, Jeff 2<sup>nd</sup>, 4-0 adopted.
- C. Consider a Resolution Approving Execution of Equipment Lease Documents (Fire Apparatus and Fire Equipment Quint) (Town Council Resolution 2018-42) Susan read the resolution and m/m to adopt, Jeff 2<sup>nd</sup>. Clinton talked about the history of the previous discussions on this topic in the Fire Board meetings. Jeff said he thinks this is a great thing to save money and help the fire department. Susan amended her motion to allow for \$360k to be spent; 4-0 adopted.
- D. Consider a Resolution Approving the Sale of a Ladder Truck to the Carmel Fire Department (Town Council Resolution 2018-44) Clinton m/m to adopt, Susan 2<sup>nd</sup>, 4-0 adopted.
- E. Consider a Resolution Approving a Declaratory Resolution and Redevelopment Plan of the Whitestown RDC Establishing the Whitestown-Maurer Commons Redevelopment Area and (2) the Order of the Plan Commission Thereto (*Resolution 2018-48*) – Dax said the RDC approved this 5-0. Susan read the resolution, and m/m to adopt, Kevin 2<sup>nd</sup>, 4-0 adopted.
- F. Consider a Resolution Approving 2019 Growth Levy Appeal (*Resolution 2018-49*)
  Susan read the resolution. Kevin m/m to adopt, Susan 2<sup>nd</sup>, 4-0 adopted.
- G. Consider Approval of a Zoning Map Amendment Petition for the Maurer (Wrecks Inc.) Property. Amend from I-1 to GB. – Dax said we will be rezoning the land, and this is to allow the process to start – Kevin m/m to authorize the 4-0 adopted.



- H. Consider a Notice of Sale of Surplus Property (2010 Pierce Freightliner Fire Engine) – Clinton read the resolution. Susan m/m to adopt, Jeff 2<sup>nd</sup>, 4-0 adopted.
- I. Consider an Expenditure Exceeding \$5,000 (Holiday Lights and Décor -NTE \$30,000 from Town Promotion Line) – Dax said we are one of the few towns who does not have holiday decorations. He said Susan Weninger did a great job on this. Kevin said it is a good idea. Kevin m/m NTE \$30k for holiday decorations, Susan 2<sup>nd</sup>, 4-0 adopted.
- J. Consider Approval of Expenditures for Environmental Due Diligence and Site Rendering for the Wrecks Site (Maurer Commons) (NTE - \$150,000 from the 2016 Perry Bond) - Dax said this doesn't technically does not need to come before the council, but **Dax** thought it would be a good idea to back the RDC in this. Kevin m/m to authorize the Town Council President to spend up to \$150k on environmental due diligence on the Wrecks site, Susan 2<sup>nd</sup>, 4-0 adopted.
- 8. TOWN ADMINISTRATION REPORT Dax talked about the summer projects wrapping up as the summer weather does as well. Dax talked about the Festival of Lights and thanked Tanya for her work on that event as well as her office on finally turning the branding point.
- 9. ADJOURN Kevin m/m to adjourn, Susan 2<sup>nd</sup>, 4-0 adjourned at 7:33pm.
