General PD Updates

The officers at WMPD have continued to work diligently in their service and protection of the Whitestown Community. While it is difficult to account for every task and accomplishment on an individual and Department wide level, some updates and highlights are below.

- ➤ WMPD's 3 newest officers, Officer Chris Barrett, Officer Betsy Crawford, and Officer Cale McCarty successfully completed Patrol School, and join Officer Sarah Anderson in our Field Training Program.
- > WMPD added our first 3 Ford Explorers to our Patrol Fleet. These new vehicles are active on Patrol and can be seen on almost all shift assignments. These vehicles look quite different as they are all black with white decals, sporting more of a "classic" police car look, as opposed to our all-white vehicles with black decals. These vehicles are also allowing WMPD the opportunity to look into the potential benefits of hybrid vehicles.
- > WMPD members completed our Summer Voluntary Fitness Testing. This is our first of 2 bi-annual voluntary fitness tests that will be completed throughout the year, allowing officers to track their fitness improvement and accomplishments throughout the year.



Officers' enforcement activity the past month yielded the following case and arrest reports.



WMPD strives to ensure that our members are mentally and physically prepared to best serve and protect our community by going above and beyond in our training efforts. This month, our officers were busy completing **816.5** hours of training. Various disciplines were covered in our training efforts including firearms, physical tactics, use of force, Emergency Medical, leadership, legal updates, administrative updates, and simulator/scenarios. Some training highlights from this busy month are below.

- ➤ All WMPD members completed Quarterly Training at the Indiana Law Enforcement Academy Tactical Engagement Center (T.E.C.). These training blocks consisted of Tactical Medicine and injured officer evacuation along with Close Quarter Battle (CQB).
- ➤ Officer Thomas Williams and Officer Josh Turner completed Crisis Intervention Team (CIT) Training held at Lebanon High School. This is part of our continuous initiative to ensure all members are CIT certified to better respond and assist those experiencing a mental crisis.
- ➤ K9 Officer Whitney Lushin attended Narcotics and Trafficking Investigation training.
- Sgt. Kevin Allen and Detective Dio Hernandez attended the Internet Crimes Against Children (ICAC) conference in Atlanta, GA.
- ➤ Officer John Pogorov attended training through the Indiana Public Retirement System on the 1977 Police & Fire pension program.
