Please sign the enclosed contract and return to our office by the program deadline of **September 30, 2023**. **If you do not wish to participate in this program or don't believe you meet eligibility requirements, you may complete boxes 15A-15C in addition to completing the highlighted boxes on the contract to refuse any potential program payments.** All contracts must be signed and returned to our office by the March 15th deadline to be considered timely filed. Signed contracts can be returned via mail, email, and fax.
