#### Public Education / PR:

- Continued work on planning and coordination for the Eclipse Event response: meeting held with all Town departments to begin to finalize response plan
- Meeting with Witham President and staff to continue to build relationship
- Hosted Frankfurt FD station building committee for tour of Station 272 and Headquarters
- On-boarded our new recruit firefighter, (Noah) Sam Sodrel. He has started in the North Side Fire Academy and will graduate in July.
- WFD Admin Staff met with PR Department to improve communications and discuss plans for future collaboration.
- Lt. Nathan Joseph (Rescue Specialist), FF/P Billy Legere (Logistics Specialist), and Chief Westrich (Task Force Leader) deployed with Indiana Task Force 1 as Type 3 team (46 Personnel) as a State resource to Winchester, IN after a devastating tornado hit the area on March 14<sup>th</sup>. Assisting the local Incident Management Team, IN-TF 1 performed primary and secondary searches of all the affected areas (over 200 structures) within the Town of Winchester and Randolph County. (Deployment was from 10:30 p.m. on Thursday, March 14<sup>th</sup> to 7:00 p.m. on Friday, March 15<sup>th</sup>.)
- Hendricks Regional Health conducted introductory educational meetings for the department's upcoming annual physicals.
- Chief Owens and Westrich met with Town GIS personnel to continue to improve department data mapping
- Chief Lanham met with PD personnel to collaborate and prepare drone operations; specifically for the eclipse event
- Chief Westrich attended county-wide EMA led meeting for the eclipse event. Attendees included EMA, Fire, EMS, Police, and Communications representatives from across the county
- Hosted Boone County Fire Chief's Association Operations Committee meeting

#### **Fire Training:**

Total Hours: 1200

The month of March has been filled with live fire scenarios, Engineer training, State Driver Operator classes, and the completion of Probationary Firefighter's "Proble packet".

An additional 90 hours of live fire training were completed across all three shifts.

3 days of Engineer/Ride-out Engineer training: Pump pressure calculations, flow rates and tactical decision making.

7 WFD members attended a state class for Driver operator general and pumper. They completed 40 hours in the classroom and pumping/driving practical testing. All 7 members have completed the course to become State Certified.

In April we will finish the Driver Operator series with the Driver Operator Aerial class.

Three of our probationary members have completed their Probie packet check sheet. This is completed by their Officer. In this packet each new member must be checked off on their knowledge and proficiency in their job duty. The Division Chief of Training sat down with each member and talked about their skills. Each member has shown they have the required knowledge and proficiency to be released from their probationary status.


### **EMS Previous Month**




### EMS Year To Date



















### Run difference from 2023 / 156 Runs, 44% Increase
