**A. Consider Approval of Crown Castle cell tower relocation feasibility study (subject to legal review).**

Todd Barker explained this was a request for approval of a feasibility study regarding the potential relocation of an existing cell tower located at 109 Hull St. in preparation of redevelopment of that parcel in the future. The Town is the property owner, and any

redevelopment would be difficult with the cell tower right in the middle of the property. The \$25,000 fee would come from either the Maple Grove or Legacy fund.

Curtis Shields, 209 Hardesty St., appeared to note he was an adjacent property owner and wanted to know what the redevelopment plans were for the property. He was told while it was not yet determined, as an adjacent property owner he would receive notice of the public hearings for this property. This step was just to see the feasibility of moving the cell tower.
