Proposal for: New walkway along CR650E from Main Street Park north 655'

This proposal includes the following:

- New trail connecting the gap north of Main Street Park.
- Cut 655' x 10' x 6"-10" deep depending on utility depth.
- Use the dirt for fill and sides. The plan is a balanced site.
- Compact subgrade, place 6" #53 stone 10' wide, 2" HMA 19mm Intermediate and 1 1/2" HMA 9.5mm Surface.
- Total 655' x 9' of finished pavement
- Grade the sides ready for seed.

Price: **\$31,000.00**

Alternate Spec: Compact subgrade, place 6" #53 stone 10' wide, 3" HMA 12.5mm Surface.

Price: **\$27,000.00**

Seed and straw blankets on disturbed soil

- ADD **\$940.00**

Place sod 4" wide along both sides, water on initial placement included only.

- ADD **\$7,200.00**

Path will mirror existing grade sloping to the west in the lower area. There are no drains along the roadway.

Payment to be made as follows: **Contract Terms**

In the event of default all expenses, including attorney's fees incurred by Triangle Asphalt in enforcing any obligation shall become due in addition to the proposal sum.

Note: This proposal may be withdrawn by us if not accepted within **30 Days**.

Terms and Conditions

We will provide and pay for Workmen's Compensation Insurance covering our employees and Public Liability and Property Damage Insurance protecting ourselves. We also will assume responsibility for the collection and payment of Social Security and State Unemployment Taxes applicable to our employees. We will furnish a Certificate of Insurance upon request.

We shall be provided with suitable access to the work area. If our work is dependent upon or must be undertaken in conjunction with the work of others, such other work shall be so performed and completed as to permit us to perform our work hereunder in a normal uninterrupted single-shift operation.

1. Price does not include Sales Tax
2. Price does not include Permits, Bonds, Fees, or Assessments of any type.
3. Price does not include Testing.
4. Price based on using INDOT stone and HMA per spec.
5. If any items are added or deleted from the proposal, contact Triangle Asphalt for pricing relating to the revised scope of work. Additional work will only be performed once written confirmation has been signed by both parties. Costs will be above the planned/estimated costs above.
6. If Triangle Asphalt is directed to install any item of work not within specifications, a Standard Waiver of Warranty will need to be signed.
7. Quote does not include restriping of existing curb, ramps, bollards, etc.
8. Pavement designs with a slope/fall of less than 1% are not guaranteed to drain.
9. In addition, Triangle Asphalt may also add amounts to the contract price to reflect fuel surcharges that are imposed by third parties in connection with any shipment of the products shown or any materials that are used in the production thereof, or any other recuperative charges that are then applied by Triangle Asphalt.
10. All HMA from Milestone plant 12 or 10.
11. Pricing is firm for completion in the 2025 construction season,
12. Quote is to be incorporated into our subcontract agreement.
