### **Total Fire Training Hours – 1130**

Each station on all three shifts participated in live fire, fire dynamic and fire behavior, training at Boone County Tower. This training was a great refresher of basic fire dynamics. It demonstrated how our tactics and aggressive firefighting can change the outcome of a fire. We reviewed the stages of fire growth and what we can do to help increase victim survival. It was a great training to get out of the house and see fire to shake off the winter rust.

The Northside Fire Academy Class 2025-04 started on February 10th. The recruits have completed three weeks of EMS and are maintaining above average scores within the class. Their physical fitness training has been focusing on functional fitness and cardio. Each recruit has started their clinicals for the class riding on the ambulance for 12 hours on the weekend as part of the certification process to become an EMT.









# Run difference from 2024 / -14 Runs, -4% Decrease






## **EMS Incident Map**








## **Fire Incident Map**








## **Vehicle Collision Incident Map**
