TOWN COUNCIL RESOLUTION NO. 2025-04**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WHITESTOWN,
INDIANA DECLARING CERTAIN PERSONAL PROPERTY TO BE SURPLUS**

WHEREAS, the Town Council of the Town of Whitestown, Indiana (“Town”) has determined that certain property owned by the Town is no longer needed and should be declared surplus; and

WHEREAS, Ind. Code § 5-22-22 *et seq.* authorizes the Town to follow certain procedures to dispose of surplus property; and

WHEREAS, in accordance with Ind. Code § 5-22-22-4, surplus items with a total estimated value of more than five thousand dollars (\$5,000) may be sold through a public auction.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF WHITESTOWN, INDIANA AS FOLLOWS:**

Section 1. The above recitals are incorporated herein by reference.

Section 2. The items listed in **Exhibit A**, attached hereto and incorporated herein by reference, belong to the Town and are no longer needed and/or are unfit for the purposes for which they were intended.

Section 3. The items listed in **Exhibit A** are hereby declared surplus property (“Surplus Property”).

Section 4. The aforementioned Surplus Property has a total estimated value of more than \$5,000.

Section 5. The Town desires to dispose of the Surplus Property in accordance with the provisions set forth in Ind. Code § 5-22-22-4 and as follows:

- a. The Town intends to engage Indianapolis Car Exchange ("ICE") and/or L.A. Cycles, both of which are auction companies that hire auctioneers licensed under IC-25-6.1, to advertise the sale of the Surplus Property at public auction.
- b. The Town shall provide ICE and/or L.A. Cycles with detailed descriptions of the Surplus Property and require ICE and/or L.A. Cycles to use the supplied description in any advertisement of the sale of the Surplus Property.
- c. The Town shall pay ICE and/or L.A. Cycles from the gross proceeds of the sale received before other expenses and liens are paid.

Section 6. This Resolution shall be effective upon its passage.
