#### TOWN OF ADVANCE, INDIANA TOWN COUNCIL RESOLUTION NO.

### A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ADVANCE, INDIANA ACCEPTING PROPERTY DECLARED TO BE SURPLUS FROM THE TOWN OF WHITESTOWN, INDIANA

**WHEREAS**, the Town Council ("Council") of the Town of Whitestown, Indiana ("Whitestown") has identified and declared certain property owned by Whitestown to be Surplus Property on March 12, 2025 pursuant to the terms set forth in Whitestown Town Council Resolution No. 2025-06, attached and incorporated herein as **Exhibit A**; and

**WHEREAS**, Ind. Code § 5-22-22 *et seq.* authorizes the Town to follow certain procedures to dispose of surplus property; and

**WHEREAS**, Indiana Code § 5-22-22-10 further authorizes Whitestown, as the purchaser of the Surplus Property, to exchange the property with another governmental body upon terms and conditions agreed upon by the governmental bodies upon adoption of a substantially identical resolution by each entity; and

**WHEREAS**, Whitestown has determined that the Town of Advance, Indiana ("Advance"), is a governmental entity who desires to use the surplus property referenced herein pursuant to the terms and conditions set forth below; and

**WHEREAS**, Advance, by and through its Town Council, now desires to accept the property deemed as surplus property by the Town of Whitestown on March 12, 2025, as identified in more detail within this Resolution.

# NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF ADVANCE, INDIANA AS FOLLOWS:

<u>Section 1.</u> The above recitals are incorporated by reference.

<u>Section 2.</u> Pursuant to Ind. Code § 5-22-22-10, on March 12, 2025, Whitestown, by and through its Council, agreed via Resolution 2025-06 to sell the following surplus property to Advance for the cost of eight thousand dollars (\$8,000.00) ("Surplus Property").

<u>Section 3.</u> The following Surplus Property is no longer needed and/or is unfit for the purposes for which it was intended to be originally used by Whitestown:

<u>Section 4.</u> The Surplus Property is to be used by Advance.

<u>Section 5</u>. Advance, by and through its Town Council, hereby accepts the aforementioned property pursuant to adopting this Resolution accepting the aforementioned surplus property for the use stated herein.

<u>Section 6.</u> This Resolution is effective upon passage of both the Whitestown Town Council Resolution No. 2025-06 and this Resolution by the Town of Advance, Indiana.
