This included 3 days of Rescue Operations Training at Boone County Training Tower in Lebanon. Crews were tasked with a rescue scenario that involved laddering a second and third story window of the training tower. Then VEIS, Vent Enter Isolate Search, each room removing victims as they were found while under limited visibility training smoke.

In April, 700 hours of training have been logged in the Recruit academy. The recruits have completed their 12th week of the Academy.

The Fire Officer 1 class held on station has concluded. 11 additional members are now state certified at the Fire Officer 1 level.





Annual Narcan Usage




EMS Incident Map








Fire Incident Map








Vehicle Collision Incident Map
