- WMPD kicked off our 3rd Citizen Academy on April 16th. Week One was an introduction to WMPD, our facility, and lastly a demonstration by K9, Gustav, and Sgt. Root. Week Two consisted of an in depth look at our Criminal Investigations Division as well as a practical exercise in evidence packaging. The 9 current students are extremely engaged and bring great questions and attitude to class every week.
- Officers Omar Alanis, Peter Boldt, and Leonard “Tre” Williams successfully graduated from the Indiana Law Enforcement Academy on April 25<sup>th</sup>, 2025. These officers worked diligently over the last 16 weeks as students at ILEA, studying and testing over various topics including: Criminal Law, Traffic Law, Firearms, Emergency Vehicle Operation, Defensive Tactics, Strategies and Tactics Of Patrol Stops, Active Shooter, Standard Field Sobriety Tests, Report Writing, and much more. We are extremely proud of Officer Alanis, Officer Boldt and Officer Williams for successfully completing the Basic Academy and are excited to get them back at WMPD and in the field.

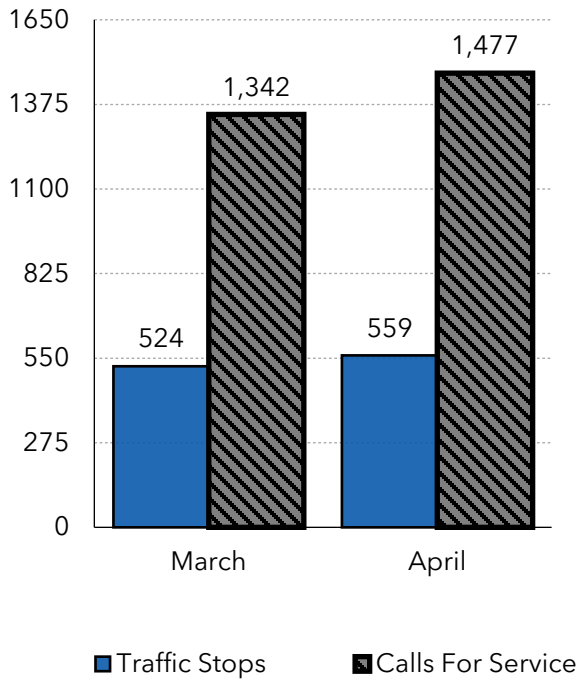

Officers’ enforcement activity the past month yielded the following case and arrest reports.

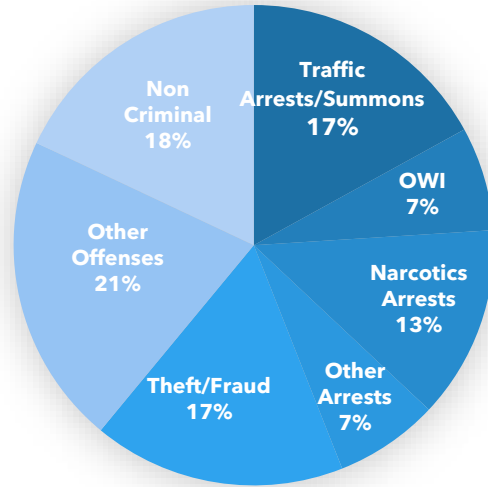

These crimes are classified into three (3) primary categories: *crimes against property* (thefts, hit and runs, criminal mischief, etc.), *crime against persons* (battery, burglary, sexual misconduct, etc.), and *cyber investigations* (forensic examination of telecommunication devices: computers, external hard drives, phones).

## Training Division

WMPD strives to ensure that our members are mentally and physically prepared to best serve and protect our community by going above and beyond in our training efforts. This month, our officers were busy completing **414 hours of training**. Various disciplines were covered in our training efforts including firearms, physical tactics, use of force, Emergency Medical, leadership, legal updates, administrative updates, and simulator/scenarios. Some training highlights from this busy month are below.

- WMPD was proud to host the FBI-LEEDA Supervisor Leadership Institute (SLI), a four-and-a-half-day cutting-edge seminar developed uniquely for supervisors and middle managers to enhance leadership competencies. While targeting first-line supervisors, the Supervisor Leadership Institute course is suitable for all police leaders. Topics of focus included law enforcement trends, defining leadership, generational effects of leadership, leadership as a lifestyle & leadership traits, building credibility & organizational credibility, four pillars of discipline, immunity & supervisor liability, & DISC assessment of personal leadership style. WMPD had 5 representatives in this class, all who are in formal and informal leadership positions.
- All department members completed monthly on-duty Defensive Tactics training.
- Sgt. Erick Frith and Ofc. Zack Thomas completed the Strategies and Tactics Of Patrol Stops (STOPS) instructor certification course through Pro Train Inc. Their recent certification gives WMPD five (5) STOPS instructors, allowing us to best train our officers for STOPS across all shifts and divisions.
- Officer Sarah Anderson completed a three day Criminal Investigative Interviewing course.
