TOWN COUNCIL RESOLUTION NO. 2025-21**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WHITESTOWN,
INDIANA DECLARING CERTAIN PERSONAL PROPERTY TO BE SURPLUS**

WHEREAS, the Town Council of the Town of Whitestown, Indiana (“Town”) has determined that certain property owned by the Town is no longer needed and should be declared surplus; and

WHEREAS, Ind. Code § 5-22-22 *et seq.* authorizes the Town to follow certain procedures to dispose of surplus property; and

WHEREAS, in accordance with Ind. Code § 5-22-22-5 and Ind. Code § 5-22-22-6, if an auctioneer is not engaged to sell the surplus item, or if a surplus item maintains a value of more than \$1,000 and is not sold through an Internet auction site, the surplus property must be sold at a public sale or by sealed bids delivered to the office of the purchasing agency before the date of the sale; and

WHEREAS, in accordance with Ind. Code § 5-22-22-5(b), the sale of the surplus property must be advertised in accordance with IC 5-3-1.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF WHITESTOWN, INDIANA AS FOLLOWS:**

Section 1. The above recitals are incorporated herein by reference.

Section 2. The item depicted in **Exhibit A**, attached hereto and incorporated herein by reference, is owned by the Town and is no longer needed and/or is unfit for the purpose for which it was intended.

Section 3. The item depicted in **Exhibit A** is hereby declared surplus property (“Surplus Property”).

Section 4. The aforementioned Surplus Property has a total estimated value greater than \$1000.00 and its sale will be advertised in accordance to IC 5-3-1.

Section 5. The Surplus Property shall be disposed of in accordance with one or more of the appropriate procedures under Ind. Code § 5-22-22 *et seq.*

Section 6. This Resolution shall be effective upon its passage.
